
I am directed to say that the Governor of Assam is pleased to convey the sanction for an amount of ₹ 11102.95 lakh (Rupees one hundred eleven crore two lakh ninety five thousand) only being the State share against the 1st installment of Central Assistance under PMAY(G) (erstwhile IAY) (including Admn. cost) (on 90:10 basis) in respect of the 27 (twenty seven) DRDAs of Assam as grants-for creation of Capital Assets State Share during the financial year 2016-17 in pursuance of the sanction and release of fund by the Govt. of India's vide letter (1) No.12013/06/2016-RH(A/c)-2-Assam dtd.16/9/2016 (2) No.12013/06/2016-RH(A/c)-2/A-Assam dtd.16/9/2016 and (3) No.12013/06/2016-RH(A/c)-2/B-Assam dtd.16/9/2016 with the following conditions :-

- (1) The works should be taken up only after observing all formalities as per Rules/Procedures before implementation of the Scheme.
- (2) The utilization certificate should be submitted to all concerned in due course.
- (3) The terms and conditions should be strictly followed / observed in terms of Govt. of India's guidelines of the schemes & instructions from time to time including the conditions laid down in the sanction order of Govt. of India.
- (4) AwaasSoft PFMS have to be used for payment, accounting and reporting as per MoRD's letter which has already been communicated.

The expenditure is debitable to the head of account "2216- Housing- 03 - Rural Housing - 105- Pradhan Mantri Awas Yojana-Gramin (PMAY-G) -0000- NULL -000-NULL - 35-grants- for creation of Capital Assets (PLAN General)-99- Others (State Share) for the year 2016-17.
