Subject : Sanction & release of recurring grant under State Plan for the resource centre in IT & Skill Dev., Handloom Skill Dev. cum production centres and Extension Centres of SIPRD Assam for the year 2016-2017

Sir,

I am directed to convey the sanction of the Governor of Assam for an amount of ₹ 275.00 lakh (Rupees two crore seventy five lakh) only as grant-in aid in respect of SIPRD, recurring grants under State Plan for the Resource Centre in IT and Skill Development, Handloom Skill Development cum production centres and Extension Centres of SIPRD for the year 2016-2017 with the following conditions:-

- (1) The expenditure under the scheme should be made strictly observing all relevant financial rules, procedures, formalities, guidelines of Govt. of Assam in force, CVC guidelines as well as Plan & Estimate as per proposal.
- (2) The Utilisation Certificate along with the audited Expenditure Statement in respect of the amount should be submitted to all concerned in due course.
- (3) Progress report and completion report should be furnished to Govt. in due course.
- (4) The fund shall be utilized only for salary.

The expenditure is debitable to the Head of Account "2501-SPRD - 01- IRDP- 800- Other Expenditure - 1341 SIRD - 000- 32- Grants-in-aid- General (Non-Salary) Plan - State Share '99-Others'" for the year 2016-17.
