ORDER

Whereas, Shi Atowar Rahman, while serving as Block Development Officer, Shri Shahjahan Ali Ahmed, while serving as Junior Engineer and Shri Sabibar Rahman, while serving as Junior Engineer at Bilasipara Development Block, Dhubri, an F.I.R was lodged against them at a complain from Shri Dhrubajyoti Das, ACS, SDO(C), Bilasipara Sub-Division, Dist. Dhubri under PS Case No. 174/2009 U/S 406/408/409/420/120(B)/418/465/471 IPC regarding irregularities in construction of Community Hall under MPLAD Fund.

Whereas, the Inspector General of Police(S), Assam, Guwahati and I/C Deputy Inspector General of Police(WR), Bongaigaon, Assam vide letter Memo No.DWR/Crime/49/DBB/2017/2378 dated 28/07/2017 submitted the report of the Investigating Officer of the case alongwith all relevant documents, requesting to accord Prosecution Sanction order against the aforesaid accused persons U/S 406/408/420/120(B)/418/465/471 IPC for early disposal of the case.

Whereas, the Disciplinary Authority after fully and carefully examining the materials placed against them, in regard to the said allegation and the circumstances of the case, disclosed commission of offense by Shi Atowar Rahman, the then Block Development Officer, Bilasipara Development Block, Dhubri (now Deputy CEO, Bongaigaon), Shri Shahjahan Ali Ahmed, the then Junior Engineer, Bilasipara Development Block, Dhubri (now APO(T), Kamrup(Metro)) and Shri Sabibar Rahman, the then Junior Engineer, Bilasipara Development Block, Dhubri (now Junior Engineer, Boitamari Development Block, Bongaigaon).

Accordingly, the Governor of Assam is pleased to accord under section U/S 406/408/409/420/120(B)/418/465/471 IPC for the prosecution of the said Shi Atowar Rahman, the then Block Development Officer, Bilasipara Development Block, Dhubri (now Deputy CEO, Bongaigaon), Shri Shahjahan Ali Ahmed, the then Junior Engineer, Bilasipara Development Block, Dhubri (now APO(T), Kamrup(Metro)) and Shri Sabibar Rahman, the then Junior Engineer, Bilasipara Development Block, Dhubri (now Junior Engineer, Boitamari Development Block, Bongaigaon) for the said offenses punishable under other provisions of law in respect of the acts aforesaid and for the taking of cognizance of the said offense by a court of competent jurisdiction.


