No.PRD-12/480/2017/PRD(B)-51 Whereas ,vide letter No.GDB-03/Esst/RD & CD/2017-18/46 dated 14/07/2017 Block Development Officer ,Gauripur Development Block,Dhubri reported that Shri Bipul Kumar Medhi, Junior Engineer,Gauripur Development Block,Dhubri has been found absent from duty since 5/07/2016 without any permission from the authority.

Whereas, Block Development Officer ,Gauripur Development Block informed him several times regarding his un authorised absence and served a letter through speed post but the letter came back without acknowledgement .His absence has hampered all the developmental works of the Government.

Whereas , under the above circumstances, the Disciplinary Authority is of the opinion that Shri Bipul Kumar Medhi, Junior Engineer, Gauripur Development Block,Dhubri be placed under suspension as per provision under Rule 6(1) of the Assam Services(Discipline & Appeal)Rules,1964 with immediate effect, pending drawal of departmental proceeding against him.

Accordingly , pending drawal of departmental proceeding, the Governor of Assam is pleased to placed Shri Bipul Kumar Medhi, Junior Engineer, Gauripur Development Block, Dhubri under suspension with immediate effect.

He shall not leave headquarter without prior permission of the Authority.

He shall be allowed subsistence allowance on production of non-engagement certificate as required under FR 53(2) of F.Rs & S.Rs.


