ORDERS BY THE GOVERNOR OF ASSAM
NOTIFICATION

Dated Dispur, the 12th September, 2017

No.PRD-12/495/2017-PRD(B)/19 : Whereas, vide letter No. DRD-15/26/2016/199, dated 22/08/2017, the Commissioner, Panchayat and Rural Development, Assam reported that Shri Nirjay Barhma, Extension Officer (Panchayat) & I/c Block Development Officer, Dotma Development Block, Kokrajhar had made payment for material components under MGNREGA for the Financial Year 2015-16, inspite of clear instruction issued vide letter No. DRD-15/26/2016/186, dated 05/06/2017, that the pending material liabilities for the financial year 2016-17 and 2017-18 only may be cleared.

Whereas, the Disciplinary Authority is of the opinion that the aforesaid act amounts to gross insubordination and indiscipline of the part of Shri Nirjay Barhma, Extension Officer (Panchayat) & I/c Block Development Officer, Dotma Development Block, Kokrajhar.

Whereas, under the above circumstances the Disciplinary Authority decides that Shri Nirjay Barhma, Extension Officer (Panchayat) & I/c Block Development Officer, Dotma Development Block, Kokrajhar be placed under suspension as per provision under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with effect from the date of arrest.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Nirjay Barhma, Extension Officer (Panchayat) & I/c Block Development Officer, Dotma Development Block, Kokrajhar under suspension with immediate effect.

He shall not leave Headquarter without prior permission of the Authority.


He shall be allowed subsistence allowance on production of Non-engagement certificate as required under FR 53 (2) of F.Rs. & S.Rs.
