No.PRD-12/2018-PRD(A)/40: Whereas, vide letter No. PDDE(II)62/2013/116, dated 29/01/2018, Addl. Commissioner, Panchayat and Rural Development, Assam forwarded a physical inspection report of Tube Well installation under 14<sup>th</sup> Finance Commissioner of Karimganj and Bagbari GPs under South Karimganj Development Block, Karimganj for the year 2015-16 (2<sup>nd</sup> installment) submitted by the Chief Executive Officer, Karimganj Zilla Parishad vide letter KZP.127/FFC/2015/Pt-2 dated 25/01/2018.

Whereas, the report revealed that Shri Saleh Ahmed Choudhury, Block Development Officer, South Karimganj Dev. Block, Karimganj did not visit any of the area during installation of the tube wells after giving the Administrative Approval due to which the quality of work platform of the tube wells was not found good and water outlet provision was not done well and all these have amounted to negligence of official duties by the Block Development Officer.

Whereas, considering the report submitted by the Chief Executive Officer, Karimganj Zilla Parishad, the Authority in Panchayat and Rural Development Department has held that Shri Saleh Ahmed Choudhury, Block Development Officer, South Karimganj Dev. Block, Karimganj be placed under suspension, pending drawal of departmental proceeding, as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Saleh Ahmed Choudhury, Block Development Officer, South Karimganj Dev. Block, Karimganj under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
