OFFICE ORDER

The Assam Service (Revision of pay) Rules 2017, has been introduced by the Govt. in the Finance Department w.e.f. 01/04/2016 vide Govt. Notification No. FPC.1/2017/Pt/2 dated 17/03/2017.

- 2. In view of the fact that the fixation of pay as per ROP Rules in respect of Extension Officer(Credit), Extension Officer(Fishery), Extension Officer(Agriculture) and Junior Engineer working in the Development Blocks and DRDA HQs in the State are to be prepared at the Govt. level in the Panchayat & Rural Development Department. It is observed from the experience of the fixation of pay as per the ROP Rules during the earlier occasion, that it takes substantial time for the Department to prepare the fixation of pay as per the ROP Rules in respect of the large numbers of above mentioned officers of the Development Blocks and DRDA HQs and payment of the revised pay to them gets inordinately delayed.
- 3. In order to expedite the fixation of pay in respect of above officers as per ROP Rules, 2017 the following decision have been taken by the Govt. in the Panchayat & Rural Development Department.
 - i. The Project Director, DRDAs and Block Development Officers are hereby entrusted with the responsibility and task of the fixation of pay of Extension Officers and Junior Engineers under respective establishment as per the Assam Services (ROP) Rules, 2017.
 - ii. The Project Directors and Block Development Officers are requested to collect the Service Book of the Junior Engineers and Extension Officers under their respective establishment from the Department by authorizing an official.
 - iii. The fixation of pay as per the Assam Services (ROP) Rules, 2017 should be completed within shortest possible time from the date of receipt of this Govt. order.
 - iv. A copy of the IPS in respect of the Junior Engineers and Extension Officers should be endorsed to Govt, for record.
 - v. All Officers to submit an undertaking to concerned DDOs to the effect that any excess drawal at any stage would be refunded to the Govt. exchequer by the concerned officer. The same is to be appended to the Service Book.
