Dated Dispur, the 11th January, 2018

No.PRD-12/564/2017-PRD(B)/214: Whereas, vide letter No. DRD-15/56/2017/9, dated 31/10/2017, Joint Director, O/o the Commissioner, Panchayat and Rural Development, Assam submitted the enquiry report into the anomalies in implementation of scheme viz. Land Development of 2 No. Hazarikapara Prathamik Sakha Campus under TFC 2014 - 15 under Sipajhar Development Block, Darrang.

Whereas, the foresaid Inquiry Officer reported that the concerned scheme has not been implemented as per the Plan & Estimate and that Shri Dhrubajyoti Baruah, Junior Engineer, Sipajhar Development Block, Darrang resorted to manipulation of the records in collusion with the G.P. President of Hazarikapara G.P.

Whereas, under the above circumstances, the Disciplinary Authority is of the opinion that Shri Dhrubajyoti Baruah, Junior Engineer, Sipajhar Development Block, Darrang be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964.

Accordingly, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Shri Dhrubajyoti Baruah, Junior Engineer, Sipajhar Development Block, Darrang under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules.
