ORDER BY THE GOVERNOR OF ASSAM
NOTIFICATION

Dated Dispur, the 2nd April, 2018

No.PRD-12/77/2018-PRD(B)/5: Whereas, vide letter No. DRD-15/42/2007/358, dated 02/04/2018, Commissioner, Panchayat and Rural Development, Assam reported that on 19th February, 2017, the FTO generation for Mandia Development Block was temporarily stopped in view of substantially high expenditure incurred by the Block under MGNREGA for the Financial Year 2016-17 vide letter No. DRD-15/17/2015/440, dated 09/02/2017 and the District was specifically asked not to capture any new demand during the period of the FTO ban and the Deputy Commissioner-cum-DPC, Barpeta was asked to submit a report regarding whether the MGNREGA schemes under Mandia Dev. Block were being executed as per the relevant Act and guidelines.

Whereas, as per the report submitted by the district authority, Shri Jadav Ch. Choudhury, the then Block Development Officer, Mandia Dev. Block, Barpeta continued to generate Muster Rolls during the period when FTO generation and capture of new demand for work under MGNREGA was stopped.

Whereas, the blatant disregard of Govt. instruction by Shri Jadav Ch. Choudhury, the then Block Development Officer, Mandia Dev. Block, Barpeta has resulted in wage liability amounting to Rs. 3.05 crores which cannot be paid since uploading of filled in Muster Rolls for previous financial years is not available in the MGNREGA MIS and this amounts to gross insubordination, indiscipline and violation of Govt. instruction.

Whereas, considering the report submitted by the Commissioner, Panchayat and Rural Development, Assam, the Discipline Authority in Panchayat and Rural Development Department has held that Shri Jadav Ch. Choudhury, the then Block Development Officer, Mandia Dev. Block, Barpeta and now posted at Chayani Barduar Dev. Block, Kamrup (Rural) be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Jadav Ch. Choudhury, Block Development Officer, Chayani Barduar Dev. Block, Kamrup (Rural) under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.


