No.PRD-12017/6/2018-PRD(C)/11: Whereas, vide letter No. CPRD(II)124/2018/27, dated 07/09/2018, Commissioner, Panchayat and Rural Development, Assam has reported that, Shri Girish Ch. Baishya, BDO, Lala Development Block, Hailakandi was absent at DISHA meeting held on 05/07/2018 without any intimation defying Govt. order. Further, Shri Girish Ch. Baishya was also absent from duty during the Assembly period w.e.f. 10th February to 15th February, 2018 without any prior intimation to the higher authority.

Whereas, It is also reported that Shri Girish Ch. Baishya had submitted a vague enquiry report against the misappropriation of MGNREGA fund for which the District Development Commissioner, Hailakandi had issued a Show Cause Notice to him but reply for the same was not submitted by Shri Girish Ch. Baishya.

Whereas, as per Report of Commissioner, Panchayat & Rural Development, Assam, performance of Shri Girish Ch. Baishya in carrying out the assignment of PMAY-G is found to be very unsatisfactory. He had released only 2% mandatory wage to the PMAY-G beneficiary depriving the poor and needy people. Again the rate of completion of PMAY-G houses (only 5% as on 4th September, 2018) is also very poor.

Whereas, the aforesaid insubordination and negligence of duty by Shri Girish Ch. Baishya, BDO, Lala Development Block, Hailakandi amounts to violation of Rule 3 of the Assam Services (Conduct) Rules, 1965.

Under the above circumstances, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Shri Girish Ch. Baishya, BDO, Lala Development Block, Hailakandi under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules.
