No.PRD-12017/6/2018-PRD(C)/13: Whereas, vide letter No. CPRD(II)124/2018/27, dated 07/09/2018, Commissioner, Panchayat and Rural Development, Assam has reported that, Shri Saroj Das, BDO, Ramkrishna Nagar Development Block & i/c BDO, North Karimganj Development Block, Karimganj has not maintained the minimum required 65% of expenditure on NRM related works which violates the Government instruction vide letter No.DRD-15/45/2018/168 dated 21st July, 2018. The aforesaid officer was also found to be negligent and incurred no expenditure on NRM related works against Ramkrishna Nagar Development Block, and found to incur only 12.67% of the total expenditure against North Karimganj Development Block.

Whereas, as per Report of Commissioner, Panchayat & Rural Development, Assam, performance of Shri Saroj Das in carrying out the assignment of PMAY-G is found to be very unsatisfactory. He had released only 4% & 8% of the mandatory wages against Ramkrishna Nagar & North Karimganj Development Block respectively to the PMAY-G beneficiary depriving the poor and needy people. Again the rate of completion of PMAY-G houses (only 4% against Ramkrishna Nagar & 8% against North Karimganj Development Block as on 4th September, 2018) is also very poor.

Whereas, the aforesaid insubordination and negligence of duty by Shri Saroj Das, BDO, Ramkrishna Nagar & North Karimganj Development Block, Karimganj amounts to violation of Rule 3 of the Assam Services (Conduct) Rules, 1965.

Under the above circumstances, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Shri Saroj Das, BDO, Ramkrishna Nagar Development Block, Karimganj under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules.
