ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, 17-08-2023

ECF No.289875/DFA/296255: Whereas, vide letter No. TMJ.37/2023/01dated 14/08/2020, the District Commissioner, Tinsukia reported that on 14-08-2023 at around 5:30 PM, Smti. Sikhamoni Gogoi, BDO, Itakhuli Dev. Block entered into the premises of the Office of the District Commissioner, Tinsukia holding a dog in a violent attitude.

Whereas, entering into the premises of O/o the District Commissioner, she vandalized the standee and notice boards, etc., erected in the entrance of the Office.

Whereas, as per report she forcibly attempted to enter into the office chamber of the District Commissioner with an intention to cause harm. She then hit the PSOs on duty who tried to restrain her from entering the office chamber of the District Commissioner. The BDO also started hitting two officers while they tried to stop her. The BDO also assaulted women police personnel who were called to the site.

Whereas, the act of Smti. Sikhamoni Gogoi, BDO is unbecoming of a Govt. servant and has violated the Para 3.1.iii. of the Assam Civil Services (Conduct) Rules, 1965 and under the above circumstances, the Disciplinary Authority is of the opinion that Smti. Sikhamoni Gogoi, Block Development Officer, Itakhuli Development Block, Tinsukia, be placed under suspension immediately as per provision under Rule 6 (1) of the Assam Services (Discipline & Appeal) Rules, 1964.

Accordingly, the Governor of Assam is pleased to place Smti. Sikhamoni Gogoi, Block Development Officer, Itakhuli Development Block, Tinsukia under suspension with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
