ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, the 1st June, 2022

No. PDB.7/2022/20: Whereas, after going through the preliminary report of the Project Director, DRDA, Kokrajhar vide letter No. KRDE-07/2008-19/257 dated 19/05/2022, Shri Bhupen Das, Block Development Officer, Hatidhura Development Block, Kokrajhar has been found to be involved in criminal offence of misappropriation of Government money by submitting irregular Bills fraudulently prior to December, 2020 and thereby drawing and disbursing the amount against those Bills in respect of Md. Yunish Ali, Retired Gram Sevak, while he was serving as Block Development Officer, Goreswar Development Block, Baksa.

Whereas, the Treasury Officer, Mushalpur Sub-Treasury, vide Memo No. MSL-1/2020-2021/77 dated 31/07/2021 had registered an F.I.R at the Mushalpur Police Station against the Block Development Officer, Goreswar Development Block for committing criminal offence of misappropriation of Government money by submitting irregular Bills fraudulently prior to December, 2020 and thereby drawing and disbursing the amount against those Bills in respect of Md. Yunish Ali, Retired Gram Sevak.

Whereas, on the basis of the Mushalpur PS Case No. 77/2021 U/S 420/409 IPC, Shri Bhupen Das, Block Development Officer, Hatidhura Development Block (the then Block Development Officer, Goreswar Development Block) was arrested by the Mushalpur Police vide Mushalpur PS Case No. 77/2021 U/S 420/409 IPC at 01:00 PM on 13th May, 2022 and subsequently sent to Judicial Custody.

Whereas, under the above circumstances, the Disciplinary Authority is of the opinion to place Shri Bhupen Das, Block Development Officer, Hatidhura Development Block, Kokrajhar under suspension as per provision of Rule 6(2) of the Assam Service (Discipline & Appeal) Rules, 1964, with effect from the date of arrest i.e. 13/05/2022 pending drawal of departmental proceeding.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Bhupen Das, Block Development Officer, Hatidhura Development Block, Kokrajhar under suspension with immediate effect from the date of arrest i.e. 13/05/2022.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules on production of non-engagement certificate.
