

**PRESS RELEASE FOR MEDICAL EXAMINATION AND DOCUMENTS  
VERIFICATION.**

The recommended candidates by the Assam Public Service Commission for appointment in the posts of Junior Engineer (Civil) under Panchayat & Rural Development Department vide Advt. No.03/2020 dated 24/06/2020 are requested to appear in the Medical Board for medical fitness examination at the **Office of the Joint Director of Health Services, Kamrup Metropolitan District, Satpukhuri, Uzanbazar, Near Brahmaputra State Guest House, Guwahati-01 from 11:00 A.M.** on the following dates as mentioned below. They are also requested to attend the medical examination with the following required laboratory test reports - (i) HB%, (ii) CBC, (iii) RBS, (iv) Liver function test, (v) Lipid Profile, (vi) Kidney function test, (vii) TSH T<sub>3</sub> T<sub>4</sub>, (viii) Urine RE, (ix) Chest X-Ray, (x) ECG and prescription of Doctors, if under treatment. The Laboratory test may be done preferably in Govt. Hospital.

Further, candidates are also requested to bring their original documents i.e. Age proof Certificate, Educational Qualification Certificate, Caste Certificate, Permanent Address proof etc. for verification on the same day & in the same venue.

Moreover, candidates are also requested to bring the notarized affidavit on character and antecedents as per prescribed format in Personnel Department O.M. issued vide No. ABP.78/2021/01 dated 18/11/2021. **OFFICE MEMORANDUM**

Dispur, dated the 18<sup>th</sup> November, 2021

No. ABP. 78/2021/01      In cancellation of this Department's OM No. ABM 50/60/300 dated 08-01-64 regarding verification of character and antecedents of persons selected for appointment in Government service, the following procedure shall apply:

1. While undertaking the exercise of appointment in Government Service, the Appointing Authorities shall inform the selected candidate/ candidates individually or through general notice to submit notarised affidavit in the format enclosed.
2. On receipt of the notarised affidavit and on being satisfied that his character and antecedent is such as to render him in all respects suitable for appointment to the service or post to which he is to be appointed, the Appointing Authority may appoint the selected candidate without obtaining Police Verification Reports.
3. The notarised affidavit shall be uploaded in the official portal of the Appointing Authority.
4. Notarised affidavit shall also be made available under provision of the RTI Act, 2005 by the Appointing Authority.
5. If any specific information contradicts the candidate's notarised affidavit, his appointment will be cancelled and he will be removed from the service. Any candidate found to have submitted false notarised affidavit may also be liable to face legal action as per law.
6. These instructions override any other provision/ instruction for appointment in State Government services or in the services of the State Government Undertakings, Local/ Autonomous Bodies or Organizations only to the extent mentioned above.
7. However, if the provision of prior Police Verification Report is specified in any Act/ Bye Laws or Regulations, the provision of this Office Memorandum shall not be applicable unless these are amended.

These instructions shall come into effect from the date of issue of this Office Memorandum.
