No. PRD-12016/1/2022-PRD(B)/110 : In the interest of public service and subject to reversion without assigning any reason, the Governor of Assam is pleased to temporarily promote the under mentioned officers from the cadre of Assistant Block Development Officer (W&C) and Assistant Block Development Officer (Panchayat) to officiate as Block Development Officers under Regulation 4(d) of the Assam Public Service Commission (Limitation of Functions) Regulation, 1951 in the scale of Pay of Rs. 30,000 – 1,10,000 + Grade Pay Rs. 12,700/- (Pay Band – 4) per month plus other allowances as admissible under rules for a period of 01 (one) year or till regularisation with the approval of the Assam Public Service Commission, whichever, is earlier, w.e.f. the date of joining.
