Whereas, it is further stated that intimation to all concerned including Sri Dilip Das, BDO, Pub-Nalbari Development Block to attend the said meeting was given over phone as was done to all other officers. But, Sri Dilip Das, BDO, Pub-Nalbari Development Block was absent in the meeting inspite of receiving information over phone and he was also not present in the head quarter without any intimation either to CEO, Zilla Parishad, Nalbari or Deputy Commissioner, Nalbari.

Whereas, the aforesaid violation of office discipline, disobedience, insubordination and negligence of official duty by Sri Dilip Das, BDO, Pub-Nalbari Development Block amounts to violation of Rule 3 of the Assam Services (Conduct) Rules, 1965 and accordingly, the disciplinary authority is of the opinion to place Sri Dilip Das, BDO, Pub-Nalbari Development Block under suspension as per provision of Rule 6 (1) of the Assam Service (Discipline & Appeal) Rules, 1964.

Accordingly, pending drawal of Departmental proceeding, the Governor of Assam is pleased to place Shri Dilip Das BDO, Pub -Nalbari Development Block under suspension as per provision of Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

The officer shall not leave head quarter without prior permission of the competent authority.

During suspension period, the Officer shall be entitled to get subsistence allowance as per Rule.
