No.PRD-12/549/2023-PRD(B)/DFA/258082: Whereas, vide letter No. DGVA/RC/2023/4095, dated 27/06/2023, the Superintendent of Police-cum-Officer in charge ACB PS reported that Md. Sabibar Rahman, Junior Engineer, Debitola Development Block, Dhubri was arrested by police in connection with an ACB PS Case No. 48/2023 U/S 7(a) of the P.C. Act 1988 (as amended in 2018) as on 26-06-2023 and he has been produced before the Court of the Hon'ble Special Judge, Assam, Guwahati on 27-06-2023 and taken on police remand for 4 (four) days.

Whereas, under the above circumstances, the Disciplinary Authority is of the opinion that Md. Sabibar Rahman, Junior Engineer, Debitola Development Block, Dhubri be placed under suspension as per provision under Rule 6 (2) of the Assam Services (Discipline & Appeal) Rules, 1964 w.e.f. the date of police custody, pending drawal of Departmental Proceeding against him.

Accordingly, the Governor of Assam is pleased to place Md. Sabibar Rahman, Junior Engineer, Debitola Development Block, Dhubri under suspension w.e.f. the date of police custody i.e. 26-06-2023.

He shall not leave headquarter without prior permission of the competent authority.

He shall be allowed subsistence allowance on production of non-engagement certificate as required under FR 53 (2) of FRs & SRs.
