Para 4: This Department has requested the concerned BDO to submit the pension papers in respect of Late Tarun Ch. Bora, Ex.- Junior Engineer as per date of his retirement after observing the liabilities, if any, as per existing rule vide letter No. PRD-12/338/2017-PRD (B)/212 dated 10/08/2020 (Annexure –I). In this connection, it is to be stated here that as per record in the Service Book at Annexure –II and in the Gradation list at Annexure –III, the date birth of Late Tarun Ch. Bora, Ex.-JE, Dhemaji Dev Block, Dhemaji was 15/05/1956 and therefore, his date of retirement was on 31/05/2016. But as per record in the Service Book, it is seen that the incumbent discharged his duties till death as on 14/07/2019. As a result, there was an overpayment of pay and allowances of Rs.22, 04,524/-(Twenty Two Lac Four thousand Five Hundred Twenty Four) Only (Annexure –IV).

Para 5: Yes, it is true. The concerned BDO has forwarded the family pension proposal of Smti Mitali Saikia w/o Late Tarun Ch. Borah, Ex.-JE, Dhemaji Dev Block, Dhemaji on 31/08/2020. But, as per record, it is seen that the proposal was not submitted through the Commissioner, Panchayat and Rural Development, Assam. Therefore, the proposal was forwarded to the Commissioner, Panchayat and Rural Development, Assam with a request to re-submit the same after examining the pension papers along with all duly filled in pension papers and Service Book vide letter No. PRD-12/338/2017-PRD (B)/259 dated 17/11/2020 (Annexure –V). Accordingly, Joint Director, O/o the Commissioner, Panchayat and Rural Development, Assam re-submitted the family pension proposal and Service Book in respect of Late Tarun Ch. Bora, Ex.-JE, Dhemaji Dev Block, Dhemaji on 17/04/2021 and was received by this department on 23/07/2021(Annexure –VI). The Family pension proposal is under process. In the meantime, this department has issued a letter to the concerned Chief Executive Officer, Zilla Parishad, Dhemaji vide letter No. PRD-12/338/2017-PRD (B)/316 dated 08/11/2021and has requested to fix responsibility on the official for whose fault Tarun Ch. Borah overstayed in service for such a long time (Annexure –VII). Thereafter, the GPF proposal of the deceased incumbent under process in this department. The matter is also marked to L.R/ Judicial Department for their views/Comment.
