ORDER

ECF No.427936/DFA/460464: The Commissioner, Panchayat & Rural Development, Assam has reported that the performance of several Blocks are very poor in terms of timely FTO generation for payment of wages to the job card holders under MGNREGA. Under Section 3(3) of MGNREGA, "workers are entitled to being paid on a weekly basis and in any case within a fortnight, of the date on which work was done". As such, these Blocks have violated the rules mentioned in the Act by not providing wages on time.

The rate of timely FTO generation is below 90% under the said Blocks. Thus, there are violations of the provisions of MGNREGA Act that timely payment of wages should be above 90% and non-payment of wages to MGNREGA workers on time is a harassment to the poor daily wage workers as well as non-compliance to the MGNREGA Act. This also reflects gross negligence and inefficiency on the part of the Programme Officer.

In view of the above, the Government in Panchayat & Rural Development Department has decided to withhold the pay of the Block Development Officers of the following Blocks until they achieve 90% timely FTO generation for payment of MGNREGA wages.
