ECF No 435769/DFA/482786: Whereas, vide letter no. DGVA/RC/2024/301, dated 09-01-2024, the Superintendent of Police, Directorate of Vigilance & Anti-Corruption, Assam cum Officer-in-Charge, ACB PS, Assam reported that on 08-01-2024, Shri Dipta Kantha Chamuah, Block Development Officer, Chamaria Development Block, Nagarbera, Kamrup was caught red-handed and arrested by a Trap team of Directorate of Vigilance & Anti-Corruption, Guwahati while accepting a bribe money amounting to Rs.8,000/-(Rupees Eight Thousand) as a part of the demanded bribe of Rs.61,000/-(Rupees Sixty One Thousand) only from a complainant; and

Whereas, the bribe money was recovered from the possession of the Block Development Officer and was seized by the team of Directorate of Vigilance & Anti-Corruption, Guwahati ; and

Whereas, the B.D.O. was arrested and produced before the Hon'ble Court of Special Judge, Assam Guwahati on 9/1/2024 and taken on Police remand for three days;

Accordingly, pending drawal of departmental proceedings, the Governor of Assam is pleased to place Shri Dipta Kantha Chamuah, Block Development Officer, Chamaria Development Block, Nagarbera, Kamrup under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with effect from the date of arrest by the team of Directorate of Vigilance & Anti-Corruption, Guwahati.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
