ORDERS BY THE GOVERNOR OF ASSAM

No.DFA/516717/446377: Whereas it has been informed by the Superintendent of Police-cum-Officer In-Charge, ACB PS, Directorate of Vigilance & Anti-Corruption, Assam vide their Letter No: DGVA/RC/2024/893 dated 06-02-2024 that Md. Emtaz Mondal, i/c BDO, Fekamari Development Block and i/c Dy. Chief Executive Officer, Zilla Parishad, South Salmara, Mankachar, Hatsingimari was arrested on 05-02-2024 in connection with ACB PS Case No: 12/2024, for demanding bribe of Rs. 10,000/ and accepting bribe money amounting to Rs.8,000/-(Eight thousand) only from the complainant and was detained in custody beyond 48 hours;

As such, pending drawal of Departmental Proceeding and in exercise of powers conferred under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964, Md. Emtaz Mondal, E.O. (Fishery) & i/c Dy. Chief Executive Officer, South Salmara Zilla Parishad, and i/c BDO, Fekamari Dev Block is placed under suspension with effect from the date of his arrest i.e. 05.02.2024 until further orders.

The Officer shall be allowed subsistence allowance as per rules.

During the period of suspension, the headquarter of Md. Emtaz Mondal, if released from judicial custody, will be same as his last place of posting, subject to review if deemed necessary.
