No.PRD-12/16/2020-PRD (B)/162: Whereas, Shri Kamaleswar Kalita, Junior Engineer, Sadiya Dev Block, Tinsukia was transferred and posted as Junior Engineer, Chayani Barduar Dev Block, Kamrup vide Govt. Notification No PRD-12/278/2017-PRD (B)/42 dated 26/02/2021 as per policy of the Government

Whereas, Government in Panchayat and Rural Development Department has not received the compliance report of the transfer & posting order from Shri Kamaleswar Kalita, Junior Engineer, Sadiya Dev Block, Tinsukia. Accordingly, instruction has been issued vide WT message to all concerned Chief Executive Officer, Zilla Parishad to release the officer and asked to join in their new place of posting by 05/06/2021 vide NO. PRD-12/16/2020-PRD (B)/150 dated 01/06/2021. But, Shri Kamaleswar Kalita, Junior Engineer, Sadiya Dev Block, Tinsukia has not reported the joining in his new place of posting. Therefore, it is observed that the incumbent, Shri Kamaleswar Kalita, Junior Engineer, Sadiya Dev Block, Tinsukia has kept the Panchayat and Rural Development Department in dark for non-intimation of his taking over charge as per his posting.

On the above circumstances, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Kamaleswar Kalita, Junior Engineer, Sadiya Dev Block, Tinsukia be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of Departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Kamaleswar Kalita, Junior Engineer, Sadiya Dev Block, Tinsukia under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
