ORDER BY THE GOVERNOR OF ASSAM  
NOTIFICATION

Dated Dispur, the 24<sup>th</sup> June, 2021

No.PRD-12/16/2020-PRD (B)/163: Whereas, Shri Lakshmi Prasad, Junior Engineer, Agomoni Dev Block, Dhubri was promoted to Assistant Engineer and posted at Tingkhong Dev Block, Dibrugarh vide Govt. Notification No PRD-12/16/2020-PRD (B)/147 dated 26/02/2021.

Whereas, Government in Panchayat and Rural Development Department has decided to promote Shri Lakshmi Prasad, Junior Engineer to the post of Assistant Engineer as per recommendation of Departmental Promotion committee meeting along with the other eligible candidates. But Shri Lakshmi Prasad, Junior Engineer, Agomoni Dev Block, Dhubri has not reported the joining in his promotional post and taking over charge in his new place of posting. Therefore, it is observed that the incumbent, Shri Lakshmi Prasad, Junior Engineer, Agomoni Dev Block, Dhubri has kept the Panchayat and Rural Development Department in dark for non-intimation of his availing the promotion and taking over charge as per his posting.

On the above circumstances, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Lakshmi Prasad, Junior Engineer, Agomoni Dev Block, Dhubri promoted to Assistant Engineer (designated) be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of Departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Lakshmi Prasad, Junior Engineer, Agomoni Dev Block, Dhubri promoted to Assistant Engineer (designated) under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.


