ORDERS BY THE GOVERNOR OF ASSAM
NOTIFICATION

Dated Dispur, the 8th March, 2022

No.PRD-12/174/2018-PRD (B)/101: Whereas, vide letter No.HJC.53/2020-21/214 dated 22/02/2022, Deputy Commissioner, Hojai has informed that Mr. Moinuddin Ahmed, Extension Officer (Fishery), Agamoni Dev. Block, Dhubri who was the then i/c BDO of Binnakandi Dev Block, Hojai is responsible for improper execution of the schemes, viz "Construction of Jamunamukh GP Office RCC Building with Commercial market Shed under 14th FC", "Construction of Students Hostel Building in Rowarpar Madrassa in Jamunagaon GP under 14th FC", "Construction of RCC Dam with Irrigation Canal at Village Sardargaon in Sutargaon GP under MGNREGA,2019-20". The execution of the said schemes is not satisfactory at all and works done are much less than the estimates.

Whereas, as per report of Deputy Commissioner, Hojai the scheme, viz "Boulder Soiling at Jamuna River at Tengakhauri from Nasir Ali House to Moinul Hoque House under MGNREGA,2019-20 has been left incomplete.

Whereas, considering the above fact, the Disciplinary Authority in Panchayat and Rural Development Department has held that Mr. Moinuddin Ahmed, Extension Officer (Fishery), Agamoni Dev. Block, Dhubri who was the then i/c BDO of Binnakandi Dev Block, Hojai be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Mr. Moinuddin Ahmed, Extension Officer (Fishery), Agamoni Dev. Block, Dhubri who was the then i/c BDO of Binnakandi Dev Block, Hojai under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
