## ORDERS BY THE GOVERNOR NOTIFICATION

Dated: Dispur, the 10th February, 2022

No. PDA.157/2021/43: As mandated under Section 64 of the Assam Panchayat Act, 1994, the Governor of Assam is pleased to sanction the formation of a new Zilla Parishad to be known as "Bajali Zilla Parishad" comprising the whole area of Bajali Development Block and Bhawanipur Development Block under Bajali district; excluding such portions as are included in a Municipality or under the authority of Town Committee or Sanitary Board of Cantonment Area or any notified area, as the case may be, contrary to it under any law for the time being in force, with its Head Quarter to be setup at Choukhuty at the allotted land of Bajali Anchalik Panchayat under Bajali Development Block. Until the Headquarter is setup at the aforesaid land, the Office of the Deputy Commissioner, Bajali shall act as the Headquarter of the Zilla Parishad.
