ORDER BY THE GOVERNOR OF ASSAM  
NOTIFICATION

No.PRD-12/16/2020-PRD (B)/161: Whereas, Shri Pradip Sarania, Junior Engineer, Nayer Alga Dev Block, Dhubri was transferred and posted as Junior Engineer, Barbhag Dev Block, Nalbari vide Govt. Notification No PRD-12/96/2017-PRD (B)/128 dated 24/02/2021 as per Guidelines of Election Commission of India on transfer & posting of officers as a Model Code of Conduct for the General Election to the Assam Legislative Assembly, 2021.

Whereas, Panchayat and Rural Development Department has not received the compliance report of the transfer & posting order from some officers and accordingly, instruction has been issued vide WT message to all concerned Chief Executive Officer, Zilla Parishad to release the officer and asked to join in their new place of posting by 05/06/2021 vide NO. PRD-12/16/2020-PRD (B)/150 dated 01/06/2021. But, this Department has not received any information regarding handing over and taking over charges form the incumbent till date.

On the above circumstances, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Pradip Sarania, Junior Engineer, Nayer Alga Dev Block, Dhubri be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of Departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Pradip Sarania, Junior Engineer, Nayer Alga Dev Block, Dhubri under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
