NOTIFICATION

Dated Dispur, the 1st February, 2019.

No.PRD-12013/5/2017-PRD(B)/45 : Whereas, vide letter No. CPRD(JE)42/2017/30, dated 17/12/2018, the Commissioner, Panchayat and Rural Development, Assam has reported that Shri Rupak Ranjan Deb, Junior Engineer, Algapur Development Block, Hailakandi, is unauthorised absent from his duties since 5th November, 2018 and hence Chief Executive Officer, Hailakandi Zilla Parishad has referred the matter to Govt. through the Commissioner, Panchayat & Rural Development, Assam for taking necessary disciplinary action against the officer.

Whereas, under the above circumstances the Disciplinary Authority has found it established by negligence of assigned official duties, unauthorised absence and poor performance of his work, Shri Rupak Ranjan Deb, Junior Engineer, Algapur Development Block, Hailakandi has violated the Rule 3 of Assam Civil Services (conduct) Rules, 1965 and hence Disciplinary Authority is of the opinion that the officer may be suspended as per provision of Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964.

Accordingly, the Governor of Assam is pleased to place Shri Rupak Ranjan Deb, Junior Engineer, Algapur Development Block, Hailakandi under suspension as per provision of Rule 6 (1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect, pending drawal of Departmental Proceeding.

The Officer shall not leave Headquarter without prior approval of competent authority.

The Officer shall be entitled to Subsistence Allowance as per Rules.
