No.PRD-12017/6/2018-PRD(C)/133: Whereas, vide letter No. LC.46/2017/ dated 17/08/2019, Deputy Commissioner, Lakhimpur has reported that after receipt of a complaint from Hon'ble MLA, Sri Debananda Hazarika, he has visited to the Dakhin Narayanpur G.P. on 15/08/2019, to inspect the scheme "Construction of Bandh cum Road from Silikhaguri Road via Phulonikhat High School to Mermukh Sports Association under MGNREGA, 2018-19".

Whereas, it is reported by Deputy Commissioner, Lakhimpur that Md. Ainul Haque Mollah, BDO, Narayanpur Development Block, Lakhimpur has made blatant irregularities during execution of the above mentioned scheme. It is stated that against the volume of earth work of 301.00 Cubic Meter amounting to Rs.68,790.00, payment in respect of wages for an amount of Rs.11,30,936.00 has already been dispensed.

Whereas, it is reported by DC, Lakhimpur that BDO, Narayanpur Dev. Block (Delinquent Officer) was present at the location during his inspection and the DO informed him that GPs were instructed to start the work on the same day i.e. on 15-08-2019.

Whereas, it is also reported that such blatant financial irregularities dispensing wages amount to the tune of Rs.11,30,936.00 without executing the work requires initiation of disciplinary proceedings against the BDO, Narayanpur Dev. Block, Md. Ainul Haque Mollah, (Delinquent Officer) and Sri Chai Hun Gohain, Junior Engineer of Narayanpur Dev. Block.

Whereas, the aforesaid insubordination and negligence of duty by Md. Ainul Haque Mollah, BDO, Narayanpur Development Block, Lakhimpur amounts to violation of Rule 3 of the Assam Services (Conduct) Rules, 1965.

Under the above circumstances, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Md. Ainul Haque Mollah, BDO, Narayanpur Development Block, Lakhimpur under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules.
