- 2) Further, in compliance with the Hon'ble Supreme Court's Order dated 10/04/2019 passed in WP(C) No.274/2009; Assam Public Works Vs. Union of India & Ors with other writ petitions, the terms stated below shall be implicated to the promoted officers who have been engaged in NRC duties:-
 - (a) The officers will undergo the stipulated training after completion of the NRC duties.
 - (b) The officers will join in the promoted post after completion of the NRC duties or subject to release by the NRC Authority.
