ORDER

Dated Dispur, the 30th December, 2019

No.PRD-12/475/2017-PRD(B)/60-A : Whereas, Shri Sudip Kumar Dhar, Junior Engineer, Hailakandi Dev. Block, Hailakandi was placed under suspension vide Notification No.PRD-12/475/2017-PRD(B)/3 dated 19/08/2017 for arrest and under Judicial Custody more than 48 hrs in connection with Hailakandi P.S. Case No.230/17.

Whereas, draft charges, statement of allegations etc. were called from the Chief Executive Officer, Zilla Parishad, Hailakandi vide WT message No.PRD-12/475/2017-PRD(B)/4 dated 13/10/2017. The Chief Executive Officer, Zilla Parishad, Hailakandi reported that charge sheet submitted by Investigation Officer in the Court of Additional Chief Judicial Magistrate, Hailakandi reflects no evidence against Sri Sudip Kumar Dhar and also reflects that he may be discharged from the liabilities of the case. In the Police report it is seen that maximum works completed and bill passed for payment & some of the payments are yet to be made.

Whereas, the Disciplinary Authority, i.e. the Governor of Assam is pleased to order that the Delinquent Officer viz Sri Sudip Kr. Dhar, Junior Engineer be exonerated from the charges levelled against him in the event of the charges being not proved against him.

Whereas, further, the Governor of Assam is pleased to order that Sri Sudip Kr. Dhar, the then Junior Engineer, Hailakandi Dev. Block, Hailakandi (u/s) shall be re-instated in service immediately.

Now, therefore, accordingly, Shri Sudip Kr. Dhar, Junior Engineer is exonerated from the charges levelled against him and the Departmental Proceeding is dropped and Sri Sudip Kr. Dhar, Junior Engineer is re-instated in service with immediate effect.

In pursuance of the above, order of re-instatement, Sri Sudip Kr. Dhar, Junior Engineer is posted at Kaliabor Dev. Block, Nagaon against the vacant post with effect from the date of taking over charge.

The period of suspension shall be treated as a period spent on duty for all purpose.
