**ORDERS BY THE GOVERNOR OF ASSAM**  
**NOTIFICATION**

In pursuance to Notification No.FPC.12/2017/4 dated 06/07/2017 issued by the Finance (PRU) Department, Govt. of Assam and subject to clearance to Departmental Proceeding/Disciplinary proceeding, the Govt. of Assam in Panchayat & Rural Development Deptt. is pleased to grant financial benefit (s) under the Modified Assured Career Progression Scheme (MACPS) to the Extension Officers (Fishery) serving under Panchayat and Rural Development Department w.e.f. 01/01/2019.

The 1<sup>st</sup> financial benefit under the MACP Scheme has been allowed after completion of 10 (ten) years of regular service, 2<sup>nd</sup> financial benefit under the MACP Scheme has been allowed after completion of 20 (twenty) years of regular service and 3<sup>rd</sup> financial benefit under MACPS has been allowed after completion of 30 years of regular services as per list below.

Since, the Extension Officers (Fishery) under Panchayat and Rural Development Department are enjoying the maximum Grade Pay of Rs.12,700/- in P.B.-4, financial benefits in the form of increments at the rate of 3% of Basic Pay shall be allowed without change in the Pay Band.


