In pursuance to Notification No.FPC.12/2017/4 dated 06-07-2017 issued by the Finance (PRU) Department, Govt. of Assam and subject to clearance of departmental Proceeding / Disciplinary Proceeding / Prosecution sanction the Govt. of Assam in Panchayat & Rural Development Deptt. is pleased to grant financial benefit(s) under the Modified Assured Career Progression Scheme (MACPS) to the Extension Officer (Credit) were serving under Panchayat & Rural Development Deptt. with effect from 01-01-2019.

The 1st financial benefit under the MACP Scheme shall be allowed after completion of 10(ten) years of regular service, 2nd financial benefit under the MACP Scheme shall be allowed after completion of 20(twenty) years of regular service and 3rd financial benefit under the MACP Scheme shall be allowed after completion of 30(thirty) years of regular service as per list below.

Since, the Extension Officer (Credit) under Panchayat & Rural Development Department are enjoying the maximum Grade Pay of Rs.9400/- in Pay Band- 3, financial benefits in the form of increment at the rate of 3% of Basic Pay shall be allowed without change in the Pay Band.


