ORDER BY THE GOVERNOR OF ASSAM

No.PRD-12/408/2017-PRD(B)/208: Whereas, vide Notification No.PRD-1/2017-PRD(B)/37, dated 20/02/2019, Shri Noor Ahmed Borbhuiya, Junior Engineer, has transferred from Banskandi Development Block, Cachar to Udalguri Development Block, Udalguri.

Whereas, the concerned JE has applied Earned Leave on medical ground w.e.f. 1/03/2019 to 30/04/2019 vide letter No. BKDB.85/JE/ESH/pt/96-97/ dated 18/03/2019. Thereafter he extended the Earned leave up to 30/06/2019, which was granted vide Notification dated 25/11/2019.

Whereas, in the mean time, a Show cause was issued against Shri Noor Ahmed Barbhuiya, the JE concerned for not compliance of Govt. order on 14/08/2019.

Whereas, the written reply of the show cause was not satisfactory and the necessary documents were also not enclosed along with the show cause reply. The concerned JE was asked to join in the new place of posting without further delay as he was transferred and posted vide Notification No.PRD-1/2017-PRD(B)/37, dated 20/02/2019. But he did not join in his new place of posting at Udalguri Development Block till date.

Whereas, under the above circumstances, the Disciplinary authority decided that Shri Noor Ahmed Barbhuiya, JE, Banskandi Dev Block, Cachar be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, with immediate effect.

Accordingly, the Governor of Assam is pleased to place Shri Noor Ahmed Barbhuiya, JE, Banskandi Dev Block, Cachar under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
