ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, the 19<sup>th</sup> May, 2020

**No.PRD-12/281/2017-PRD(B)/84:** Whereas, after going through the First Information Report of the Chief Executive Officer, Lakhimpur Zilla Parishad lodged against the i/c BDO, Ghilamara Dev. Block in Ghilamara PS, the Commissioner, Panchayat and Rural Development, Assam has reported vide letter No. PDDE(II)53/2020/14, dated 16/05/2020, that Shri Dipul Chamuah, Extension Officer (Fishery) & i/c BDO, Ghilamara Development Block, Lakhimpur has been found to be involved in fraudulent drawal of PMAY(G) fund under Ghilamara Dev. Block, Lakhimpur.

Whereas, as per the First Information Report of the Chief Executive Officer, Lakhimpur Zilla Parishad, Shri Dipul Chamuah, Extension Officer (Fishery) & i/c BDO of Ghilamara Dev. Block, Lakhimpur has made blatant irregularities in payment of wages to the beneficiaries of Pradhan Mantri Awas Yojana-Gramin (PMAY-G) at Subansiri Gaon Panchayat under Ghilamara Dev. Block, Lakhimpur.

Whereas, as per the First Information Report, it is also alleged that Shri Dipul Chamuah, Extension Officer (Fishery) & i/c BDO of Ghilamara Dev. Block, Lakhimpur is involved in drawing wage bill through Master Roll Payment Voucher by making payment to different persons using their ID who are not actual beneficiaries of PMAY-G.

Whereas, the aforesaid insubordination and negligence of duty by Shri Dipul Chamuah, Extension Officer (Fishery) & i/c BDO of Ghilamara Dev. Block, Lakhimpur amounts to violation Rule 3 of the Assam Services (Conduct) Rules, 1965.

Whereas, considering the report submitted by the Commissioner, Panchayat and Rural Development, Assam, the Discipline Authority in Panchayat and Rural Development Department has held that Shri Dipul Chamuah, Extension Officer (Fishery) & i/c BDO, Ghilamara Development Block, Lakhimpur be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against him.

Accordinly, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Shri Dipul Chamuah, Extension Officer (Fishery) & i/c BDO, Ghilamara Development Block, Lakhimpur under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed to draw subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
