No.PRD-12/164/2017-PRD(B)/141: Whereas, after going through the preliminary enquiry report of the Chief Executive Officer, Kamrup Zilla Parishad and letters vide No. KRP-25/2002-2003/Pt-II/2017/4010-A dated 20/05/2020 and No. KRP-25/2002-2003/Pt-II/2017/4087 dated 01/07/2020 of the Project Director, DRDA, Kamrup, Amingaon, the Commissioner, Panchayat and Rural Development, Assam has reported vide letter No. CPRD/14th FC/ 48/2020/234 dated 20/07/2020, that Syed Jainal Hussain, BDO, Goroimari Development Block, Kamrup has been found to be delinquent in discharging his duties during cash distribution @Rs.1000/- to Non NFSA/Ration Card holder families during National Lock Down in connection with COVID-19 and was arrested by the Chaygaon P.S. on 18/05/2020 under Case No. 401/2020 U/S-120(6)/467/409 9PC and subsequently sent to Judicial Custody.

Whereas, under the above circumstances, the Disciplinary Authority is of the opinion to place Syed Jainal Hussain, BDO, Goroimari Development Block, Kamrup under suspension as per provision of Rule 6(2) of the Assam Service (Discipline & Appeal) Rules, 1964, with effect from the date of arrest i.e. 18/05/2020 pending drawal of departmental proceeding.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Syed Jainal Hussain, BDO, Goroimari Development Block, Kamrup under suspension with immediate effect from the date of arrest i.e. 18/05/2020.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules on production of non-engagement certificate.


