Dated Dispur, the 27th August, 2020

No.PRD-12019/67/2019-PRD(B)/33: Whereas, vide Notification No.PRD-1/2017-PRD(B)/36-C, dated 31/12/2018, Shri Sudip Sen, Junior Engineer, was transferred from Lala Development Block, Hailakandi to Jorhat Central (Sipahikhola) Development Block, Jorhat. But he did not join at new place of posting till date.

Whereas, in the mean time, a Show cause was issued against Shri Sudip Sen, the Junior Engineer concerned for not compliance of Govt. order on 14/08/2019 and the written reply of the show cause received on 31/08/2019 was not satisfactory.

Whereas, under the above circumstances, the Disciplinary authority decided that Shri Sudip Sen, Junior Engineer, Lala Development Block, Hailakandi be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, with immediate effect.

Accordingly, the Governor of Assam is pleased to place Shri Sudip Sen, Junior Engineer, Lala Development Block, Hailakandi under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave head quarter without prior permission of the competent authority.


