## ORDER

Dated Dispur, the 20th February, 2021

No.PRD-12/408/2017-PRD (B)/376: Whereas, vide Notification No.PRD-1/2017-PRD(B)/37, dated 20/02/2019, Noor Ahmed Borbhuiya, JE has transferred from Banskandi Dev Block, Cachar to Udalguri Dev Block, Udalguri.

Whereas, the concerned JE has applied Earned Leave on medical ground w.e.f 01/03/2019 to 30/04/2019 vide letter No. BKDB.85/JE/ESH/pt/96-97/ dated 18/03/2019. Thereafter, he extended the earned leave up to 30/06/2019, which was granted vide Notification dated 25/11/2019.

Whereas, in the meantime, a show cause was issued against Shri Noor Ahmed Borbhuiya, the JE concerned for not compliance of Govt. Order on 14/08/2019. The written reply of the show cause was not satisfactory and necessary documents were also not enclosed along with the show cause reply. The concerned JE was asked to join in Udalguri Dev Block, Udalguri without further delay on 21/12/2019. But he did not join in new place of posting.

Whereas, under the above circumstances, the concerned JE was placed under suspension vide Notification No. PRD-12/408/2017-PRD (B)/208 dated 30/04/2020.

Whereas, after careful examination of the written statement of defence submitted by the above-named Charged Officer and the materials on records, and being not satisfied with the statement of defence, the Disciplinary Authority decided to cause an enquiry and accordingly, Inquiry Officer and Presenting Officer were appointed vide Govt. Notification No. No. PRD-12/408/2017-PRD (B)/214 dated 14/09/2020.

Whereas, the concerned charged officer was re-instated in service and posted at Tingkhong Dev Block, Dibrugarh vide Notification No. PRD-12/408/2017-PRD (B)/218 dated 30/09/2020.

Whereas, the concerned JE has submitted an application on 12/11/2020 to modify his transfer order on medical ground as he has been suffering from serious schizophrenia and other physical and mental illness and undergoing medical treatment. Moreover, he is on the verge of retirement from service on 30/11/2021. In this connection, Hon'ble Gauhati High Court passed an order dated 21/12/2020 in WP(C) No.5506/2020, Wherein, it is directed to the respondent No.1 i.e. Principal Secretary, P&RD to consider the representation dated 12/11/2020 and pass a speaking order within an outer limit period of four weeks from the date of received of certified copy of this order.

As such, considering the above fact, the Governor of Assam is pleased to consider the posting order after re-instatement in service issued vide Notification No. PRD-12/408/2017-PRD (B)/218 dated 30/09/2020 in respect of Noor Ahmed Barbhuiya, J.E. Tingkhong Dev Block, Dibrugarh and post at South Hailakandi Dev Block, Hailakandi against vacant post with effect from the date of taking over charge until further order.
