No.PRD-12/101/2020-PRD(B)/80: Whereas, Shri Sanjit Bharali, Block Development Officer, Chenga Dev Block, Barpeta was transferred and posted as Block Development Officer, Titabor Dev Block, Jorhat vide Govt. Notification No PRD-12/101/2020-PRD(B)/9 dated 09/02/2021 as per Guidelines of Election Commission of India on transfer & posting of officers for the ensuing General Election to the Assam Legislative Assembly, 2021.

Whereas, the Joint Secretary to the Govt. of Assam & Addl. Chief Electoral Officer, Election Department has forwarded a copy of complaint petition vide letter No. ELE.205/2021/146 dated 27/03/2021 and requested to take appropriate action with intimation Election Department.

Whereas, as per information received from Chief Executive Officer, Barpeta on 13/04/2021, it appears that Shri Sanjit Bharali, Block Development Officer, Chenga Dev Block, Barpeta has not joined at Titabor Dev Block, Jorhat, which violate the MCC norms.

On the above circumstances, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Sanjit Bharali, Block Development Officer, Chenga Dev Block, Barpeta be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of Departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Sanjit Bharali, Block Development Officer, Chenga Dev Block, Barpeta under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
