NOTIFICATION

No.PRD-12019/37/2018-PRD (B)/98: Whereas, Deputy Commissioner & District Election Officer, Nagaon vide letter No.NE(AE)37/2021/5 dated 06/04/2021 has informed that Shri Utpal Gayan, Assistant Engineer, Lawkhowa Dev Block, Nagaon was appointed as Presiding Officer under section 26 of the Representation of the People-Act, 1963 (43 of 1951) in connection with General Election to the Assam Legislative Assembly-2021 at polling Station No. 203, Satlunga LP School (East) of 82 Raha (SC) LAC in which poll was held on 01/04/2021.

Whereas, as per report of Assistant Commissioner, Nagaon & Venue in Charge of Material Distribution Venue at Dawson H.S. & M.P. School, Nagaon, the above mentioned personal was in an inebriated condition under the influence of alcohol on the material distribution day i.e. day before poll on 31/03/2021. Therefore, the above mentioned incumbent could not be sent to the Polling Station to perform his assigned work as Presiding Officer.

Whereas, Deputy Commissioner & District Election Officer, Nagaon has sent a replacement in place of Shri Utpal Gayan and for this irresponsible act of Shri Utpal Gayan, Assistant Engineer, Lawkhowa Dev Block, Nagaon has led to immense trouble to the district election machinery.

Whereas, considering the above fact, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Utpal Gayan, Assistant Engineer, Lawkhowa Dev Block, Nagaon be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Utpal Gayan, Assistant Engineer, Lawkhowa Dev Block, Nagaon under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
