**No.PRD-12/114/2020-PRD(B)/131:** Whereas, the Commissioner, Panchayat and Rural Development, Assam has furnished an Enquiry Report in respect of Goroimari Development Block, Kamrup vide letter No. CPRD/MGNREGA/28/2021/9 dated 27/07/2021, whereby it is reported that Smti Moni Devi, BDO, Goroimari Dev. Block, Kamrup has been found to be involved in permitting 4 (four) nos. of Computer Assistants of the Goroimari Development Block for jointly using the Programme Officer (P.O.) Login ID in NREGA software; and


Whereas, the aforesaid gross indiscipline, disintegrity and violation of Govt. Guidelines and negligence of duty by Smti Moni Devi, BDO, Goroimari Dev. Block, Kamrup amount to violation of Rule 3 of the Assam Services (Conduct) Rules, 1965; and

Whereas, considering the report submitted by the Commissioner, Panchayat and Rural Development, Assam, the Disciplinary Authority in Panchayat and Rural Development Department has held that Smti Moni Devi, BDO, Goroimari Dev. Block, Kamrup be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against her.

Accordingly, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Smti Moni Devi, BDO, Goroimari Dev. Block, Kamrup under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed to draw subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.


