No. 12017/9/2021/PRD(B)/26: Whereas, after going through the enquiry report dated 19/07/2021 conducted by Smt. Ditimoni Pegu, ACS, Joint Secretary to the Government of Assam, Panchayat & Rural Development Department, Shri Monser Ali Mondal, Executive Engineer, Dhubri Zilla Parishad (Under order of Transfer to South Salmara Mankachar Zilla Parishad) has been found according Technical Sanctions to the works which are not permissible work under MGNREGA. Moreover, he is found responsible for according technical sanctions to the estimates with split works and prepared with items not included in SECURE and also found responsible for not obtaining vetting from the concerned department. As such, he is charged with gross irregularities and misappropriation of Government money in implementation of MGNREGA scheme in Dhubri Vidhan Sabha Constituency, Dhubri for the financial year 2020-2021.

Whereas, under the above circumstances, the Disciplinary Authority is of the opinion to place Shri Monser Ali Mondal, Executive Engineer, Dhubri Zilla Parishad under suspension as per provision of Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Monser Ali Mondal, Executive Engineer, Dhubri Zilla Parishad under suspension as per provision of Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.

The Officer (under suspension) shall be allowed to draw subsistence allowance as per rules on production of non-engagement certificate.
