No.PRD-12/63/2021-PRD(B)/25: Whereas, an enquiry was conducted by the Additional Commissioner, Panchayat & Rural Development, Assam on misappropriation of fund under MGNREGA in Gauripur Development Block, Dhubri; and

Whereas, as per the enquiry report it is found that the Block Development Officer and Programme Officer, Gauripur Development Block, Dhubri, Shri Khabir Uddin Ahmed is responsible for taking up and executing works which are not in the permissible work list of MGNREGA; and

Whereas, the Block Development Officer, Gauripur Dvelopment Block, Shri Khabir Uddin Ahmed has also been found responsible for making payment of wages without procuring the materials and engaging semi skilled/skilled workers; and

Whereas the Block Development Officer is also found responsible for making payment to vendors without supply, fitting and fixing of signboards at the worksites; and

Whereas Shri Khabir Uddin Ahmed, Block Development Officer, Gauripur Development Block, Dhubri was arrested by Dhubri Police on 05-09-2021in connection with Case No.1097/2021 U/S 120(B)/406/409/465/468/471/420/511 IPC and subsequently sent to judicial custody; and

Whereas, under the above circumstances, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Khabir Uddin Ahmed, Block Development Officer, Gauripur Dev. Block, Dhubri be placed under suspension as per provision of Rule 6(2) of the Assam Service (Discipline & Appeal) Rules, 1964 w.e.f. the date of arrest i.e. 05/09/2021 pending drawal of departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Khabir Uddin Ahmed, Block Development Officer, Gauripur Dev. Block, Dhubri under suspension as per provision of Rule 6(2) of the Assam Service (Discipline & Appeal) Rules, 1964 with effect from the date of arrest i.e. 05/09/2021.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
