**ORDER**

Whereas, the Provisional Gradation list of Assistant Engineers under Panchayat & Rural Development Department was published vide Govt. letter No. PRD-12/16/2020-PRD(B)/62 dated 11/03/2020 and uploaded in the Department's website ([www.pnr.assam.gov.in](http://www.pnr.assam.gov.in)) giving 30 (thirty) days time for submission of claims and objections if any from the incumbents concerned.

Whereas, during the time provided for submission of claims and objections, no claim and objection has been received till expiry of the stipulated time period.

Whereas, during the time of scrutiny, it was noticed that Shri Dilip Kr. Nath, Junior Engineer and Smt. Sumita Deb Sinha, Junior Engineer, promoted to the post of Assistant Engineer vide Govt. Notification No. PRD-12/570/2019-PRD(B)/94 dated 26/12/2019 and posted at Fekamari Dev. Block, South Salmara & Mankachar and Pakabetbari Dev. Block, Barpeta respectively had not joined at their respective place of posting as Assistant Engineer in pursuance of the Govt. Notification No. PRD-12/570/2019-PRD(B)/94 dated 26/12/2019. Meanwhile, on further scrutiny it also came to notice that there was no record of the service status of these two incumbents in the department. Accordingly, a letter was served to all Chief Executive Officer, Zilla Parishads and Project Director, DRDAs seeking the service status of Shri Dilip Kr. Nath, Junior Engineer and Smt. Sumita Deb Sinha, Junior Engineer vide Govt. letter No. No. PRD-12/16/2020-PRD(B)/123 dated 13/05/2020.

Whereas, in response to the Govt. letter No. No. PRD-12/16/2020-PRD(B)/123 dated 13/05/2020 the Chief Executive Officer, South Salmara & Mankachar Zilla Parishad vide letter No. ZPSSM-9/Estt./Block/2019/36 dated 19/05/2020 has submitted a service status report in connection with Shri Dilip Kr. Nath, Junior Engineer wherein it is reported that Shri Dilip Kr. Nath has not joined in his duty as Assistant Engineer at Fekamari Dev. Block.

Whereas, in response to the Govt. letter No. No. PRD-12/16/2020-PRD(B)/123 dated 13/05/2020 the Chief Executive Officer, Cachar Zilla Parishad vide letter No. CZP-161/G. Corresp./Misc/Pt-II/2018-19/81 dated 21/05/2020 has submitted a service status report in connection with Smt. Sumita Deb Sinha, Junior Engineer wherein it is reported that Smt. Sumita Deb Sinha, Junior Engineer, Katlicherra Dev. Block was transferred and posted at Sonai Dev. Block vide Govt. Notification No. PRD-12/403/2017-PRD(B)-12 dated 01/06/2018 and accordingly she was released from the Katlicherra Dev. Block vide letter No. KDB-1/Esstt./Pt-I/2016-17/14 dated 02/07/2018. However, it is also reported that she has been unauthorisely absent since her joining in the Sonai Dev. Block on 03/07/2018.

In view of the above, it is decided to keep the two incumbents Shri Dilip Kr. Nath, Junior Engineer and Smt. Sumita Deb Sinha, Junior Engineer, out of Final Gradation List of the Assistant Engineers till joining of the incumbents in the promoted post of Assistant Engineer.
