Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Sushil Tamuli, Junior Engineer, Chinthong Dev Block, West Karbi-Anglong promoted to Assistant Engineer (designated) under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
