Also, instances of exhibiting unruly behavior, use of unparliamentary words against Senior Government Officials and showing of ill temperament etc. have been cited against Shri Manoj Kumar Barman, Assistant Development Commissioner, Panchayat & Rural Development by the Commissioner, Panchayat & Rural Development, Assam

Whereas, under the above circumstances, the Disciplinary Authority is of the opinion to place Sri Manoj Kumar Barman, Assistant Development Commissioner, Panchayat & Rural Development, Assam and i/c Block Development Officer, Madhupur Dev. Block, Nalbari under suspension as per provision under Rule 6 (1) of the Assam Services (Discipline & Appeal) Rules, 1964.

Accordingly, pending drawal of Departmental Proceeding, the Governor of Assam is pleased to place Sri Manoj Kumar Barman, Assistant Development Commissioner, Panchayat & Rural Development, Assam and i/c Block Development Officer, Madhupur Dev. Block, Nalbari under suspension as per provisions of Rule 6 (1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer shall not leave headquarter without prior permission of the competent authority.

The Officer shall be entitled to subsistence allowance as per rules.
