ORDER BY THE GOVERNOR OF ASSAM  
NOTIFICATION

**No.PRD-12/68/2019-PRD(B)/32:** Whereas, vide letter No. KDC.2/DRDA/2021/297, dated 20/05/2021, the Deputy Commissioner, Karimganj has stated that he has examined the report of Shri Saroj Das, Block Development Officer, Dullavcherra Dev. Block, Karimganj dated 15/05/2021 regarding implementation of schemes under MGNREGA and PMAY (G) for the year, 2020-21 and made multiple physical verification in the Dullavcherra Dev. Block, Karimganj and thereafter noticed huge anomalies in the field in respect of both physical & financial aspects against the schemes under MGNREGA and has also noticed poor performance in implementation of PMAY (G) Scheme for the year, 2020-21; and

Whereas, as per the report of the Deputy Commissioner, Karimganj, Shri Saroj Das, Block Development Officer, Dullavcherra Dev. Block, Karimganj has committed significant financial irregularities during implementation of schemes under MGNREGA and poor performance in implementation of PMAY (G) Scheme for the year, 2020-21; and

Whereas, considering the report of the Deputy Commissioner, Karimganj, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Saroj Das, Block Development Officer, Dullavcherra Dev. Block, Karimganj be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Saroj Das, Block Development Officer, Dullavcherra Dev. Block, Karimganj under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.
