ORDER BY THE GOVERNOR OF ASSAM  
NOTIFICATION

Dated Dispur, the 18<sup>th</sup> March, 2021

**No.PRD-12/101/2020-PRD(B)/24:** Whereas, Shri Paramananda Saikia, Block Development Officer, Pub Chaiduar Development Block, Biswanath was transferred and posted as Block Development Officer, Rangia Development Block, Kamrup vide Govt. Notification No.PRD-12/101/2020-PRD(B)/9, dated 09/02/2021 as per Guidelines of Election Commission of India on transfer & posting of officers for the ensuing General Election to the Assam Legislative Assembly, 2021.

Whereas, the Joint Secretary to the Govt. of Assam & Addl. Chief Electoral Officer, Election Department has furnished a copy of the letter No.61/1/AS-LA/2021/132 dated 05/03/2021 as forwarded by the Election Commission of India and requested to cause an enquiry into the matter and submit a report on or before 12<sup>th</sup> March, 2021 for onward submission to ECI.

Whereas, as per telephonic conversation with i/c BDO, Rangia Dev. Block, Kamrup on 15/03/2021, it appears that Shri Paramananda Saikia, BDO, Pub Chaiduar Dev. Block, Biswanath has not joined at Rangia Dev. Block, Kamrup which violates the MCC norms.

On the above circumstances, the Discipline Authority in Panchayat and Rural Development Department has held that Shri Paramananda Saikia, Block Development Officer, Pub Chaiduar Dev. Block, Biswanath be placed under suspension as per provision of Rule 6 (1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Paramananda Saikia, Block Development Officer, Pub Chaiduar Dev. Block, Biswanath under order of suspension as per provision of Rule 6 (1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.


