ORDER BY THE GOVERNOR OF ASSAM  
NOTIFICATION

Dated Dispur, the 24<sup>th</sup> June, 2021

No.PR-12/16/2020-PRD (B)/164: Whereas, Shri Zekib Saleh Kumar, Junior Engineer, South Karimganj Dev Block, Karimganj was promoted to Assistant Engineer and posted at Diyang Valley Dev Block, Dima Hasao vide Govt. Notification No PRD-12/16/2020-PRD (B)/147 dated 26/02/2021.

Whereas, Government in Panchayat and Rural Development Department has decided to promote Shri Zekib Saleh Kumar, Junior Engineer, to the post of Assistant Engineer as per recommendation of Departmental Promotion Committee meeting along with the other eligible candidates. But, Shri Zekib Saleh Kumar, Junior Engineer, South Karimganj Dev Block, Karimganj has not reported the joining in his promotional post and taking over charge in his new place of posting. Therefore, it is observed that the incumbent, Shri Zekib Saleh Kumar, Junior Engineer, South Karimganj Dev Block, Karimganj has kept the Panchayat and Rural Development Department in dark for non intimation of his availing promotion and taking over charge as per his posting.

On the above circumstances, the Disciplinary Authority in Panchayat and Rural Development Department has held that Shri Zekib Saleh Kumar, Junior Engineer, South Karimganj Dev Block, Karimganj promoted to Assistant Engineer (designated) be placed under suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964, pending drawal of Departmental proceeding against him.

Accordingly, pending drawal of departmental proceeding, the Governor of Assam is pleased to place Shri Zekib Saleh Kumar, Junior Engineer, South Karimganj Dev Block, Karimganj promoted to Assistant Engineer (designated) under order of suspension as per provision of Rule 6(1) of the Assam Service (Discipline & Appeal) Rules, 1964 with immediate effect.

The Officer (under suspension) shall be allowed subsistence allowance as per rules.

The Officer (under suspension) shall not leave headquarter without prior permission of the competent authority.


